

Objectives and activities

The School for a Culture of Peace (ECP) was founded in 1999 with the purpose of organizing academic, research and intervention activities related to the culture of peace, including conflict analysis, prevention and transformation, peace education, disarmament and the promotion of human rights.



To meet these objectives the ECP focuses its work in the following areas:

Research: Dissemination of knowledge on conflicts, peace processes, parallel diplomacy, the gender dimension in conflicts and peacebuilding, transitional justice and peace education. This is accomplished through:

- Daily monitoring and analysis of the international situation in the areas of armed conflict and tension.

- Daily monitoring and analysis of ongoing peace processes or negotiations in either the formal or exploratory stages.

- Analysis and daily monitoring of transitional justice processes.

- Analysis of the gender dimension in all of the areas of research the ECP is currently active in.

■ Educational activities: Promotion and development of the knowledge, values and skills of peace education through activities such as: - University Teaching: "Post-graduate Certificate in the Culture of Peace" at the Autonomous University of Barcelona (UAB). Courses on "Culture of Peace and conflict management" and "Educating for peace and during the conflict" at the UAB;

- Training and consulting work to guide professionals (teachers, social workers, etc.) in how to include peace education in their daily work;

- Increasing awareness of the culture of peace in the Catalan and Spanish civil society through different educational and training activities.

Intervention:

- Intervention in conflicts to facilitate dialogue between the conflicting parties;

- Consulting services on conflict, peacebuilding and peace education for different types of local and international actors;

- Assistance for local actors in the area of peacebuilding.

Areas of work

The Peace Processes Programme keeps track of all ongoing exploratory and formal peace negotiations in the form of case studies and comparative analyses of the different elements in these processes. This information is also used when writing the chapters dealing with peace processes in the Barometer (quarterly) and Alert (annual) publications, and is the basis for the Yearbook on Peace Processes, the most important publication in the programme. The programme also intervenes in conflicts in those cases when it is felt that it may facilitate the initiation of negotiations or consolidate existing dialogues. Accordingly, it seeks to exert some influence in contexts where an opportunity exists to make a specific contribution, although the interventions are normally behind the scenes.

In 2013 the Programme published a yearbook on peace processes, as well as a series of reports and articles. It provided teaching in Catalonia, did international consulting work, drove parallel diplomacy initiatives, and worked with various Spanish and foreign media organizations. Given its transversal organizational structure, several ECP team members have participated in this programme. The director of the programme, Vicenç Fisas, holds the UNESCO Chair in Peace and Human Rights and is the Director of the School for a Culture of Peace.


The **Conflicts and Peacebuilding Programme** monitors and analyzes armed conflicts, situations of tension, gender and peacebuilding. The programme analyzes all of the ongoing armed conflicts and situations of tension in Africa, Asia, America, Europe and the Middle East.

In 2013 the programme produced an annual report on conflicts, human rights and peace-building, as well as periodicals covering the programme's thematic and geographic lines of research. In 2013 the programme launched the Conflict and Peacebuilding Observatory project, which aims to shed light on the various forms of contemporary violence and to raise awareness of the peace initiatives currently being implemented in various contexts, including those promoted by women. During the year the programme has also expanded the online Database on Conflicts and Peacebuilding with information regarding peace negotiations in contexts of tension. The team has also continued to regularly update all the database content. Relevant information on the evolution of the different contexts has been added, including armed conflicts, situations of sociopolitical tension, and negotiation processes related to conflicts. Both projects are supported by the Norwegian Ministry of Foreign Affairs.

The main activities of the **Education for Peace Programme** include training, producing informational and educational materials, and research. The training activities are aimed at teachers and people in the world of education, university students, care professionals providing municipal services to people, and other actors whose participation has a multiplying effect in disseminating information at the community, civic and association levels. All these activities aim to promote strategies and skills for nonviolent conflict transformation and the development of a culture of peace, as well as to encourage the dissemination of the materials, resources and activities that the education for peace programme offers.

In addition to its usual activities, in 2013 the programme has stepped up efforts to reflect on the practice of conflict transformation and the promotion of peace at the municipal level, both through training programs for municipal workers and in the area of research by adapting the theoretical knowledge of conflict transformation to public reality. Also, as part of the Competencies and Education for Development programme, advances have been made in the creation of a syllabus for peace education consistent with the current official competency-based curriculum.

Research and Communication Main Publications

The most prominent publications of the School for a Culture of Peace in 2013 include the Yearbooks on peace processes and Alert as well as other conflict analysis and peace education reports. Electronic versions of all of these publications are available on the School for a Culture of Peace website.

Fisas, Vicenç. Yearbook on Peace Processes 2013. Barcelona: Icaria editorial.

This **Yearbook on Peace Processes** analyzes the peace negotiations that are underway in Africa, Asia, America, Europe and the Middle East, and includes both formal and exploratory dialogues. The report provides details on the evolution of the processes, whether they are successful or not, and identifies and analyzes the factors that contribute to crisis and the main components of these dialogues. In some cases analysis is provided for negotiations or exploratory talks that are considered to be partial or limited in that they do not encompass all the armed groups present in the country (in Spanish and English).

VV. AA. *Alert 2013! Report on conflicts, human rights and peacebuilding.* Barcelona: Icaria editorial.

This Yearbook analyzes the state of the world in four areas: armed conflicts, tensions, peace processes and the gender dimension in peacebuilding. Alert! provides an overview of the state of the world and discusses dynamics that may have a global impact. A comparative regional overview is provided with an analysis of the most significant events of 2012 and a discussion of the nature, causes, dynamics, actors and consequences of the main scenarios of armed conflict and socio-political tensions in the world. The report identifies global trends, early warning and risk factors, and opportunities for peacebuilding and the prevention or resolution of conflicts (in Spanish and English).

Caireta, Marina. *La construcció de pau en el marc escolar. L'educació per la pau i la convivència escolar: dues mirades complementàries.* [Building peace in the school setting. Peace education and life at school: two complementary views.] Barcelona-Antwerp. ECP-Evens Foundation.

This publication provides an overview of the educational project awarded the 1st Evens Prize for Peace Education. It explores the possibilities and opportunities of training teachers in peace education in a school setting, including everything from how to promptly manage conflicts to reassessing school structures. The book also systematizes European best practices used by organizations that were finalists in the Evens Prize for Peace Education (in Catalan and English).







Royo Aspa, Josep M^a. *RD Congo, un estat de la qüestió*. [DR Congo, the state of the question] *Reports* 07/2013 Institut Català International per la Pau

This report describes the war that is ravaging DR Congo, which continues to be one of the most serious and forgotten conflicts currently underway. The report explains the causes and history of the conflict, provides an analysis of the current situation and the main armed actors, and identifies the main obstacles and challenges ahead for the resolution of the conflict (in Catalan).



VVAA. Barometer. Barcelona: ECP. (Nº 31, 32 and 33)

A quarterly report that analyzes events around the world during each quarter in four sections: armed conflicts, tensions, peace processes, and gender and peacebuilding. The report allows specific topics and countries to be tracked, and provides updates to the information in the annual Alert! publication. All of the numbers of the Barometer are available on the website of the School of a Culture of Peace (in Spanish).

Anàlisi dels llibres de text de ciències socials des d'una perspectiva de pau (Cuarto de ESO, 2008-2011) [Analysis of social science textbooks from the perspective of peace (Fourth grade of secondary education, 2008-2011)]. Barcelona: International Catalan Institute for Peace.

This research analyzes six thematic areas from social science textbooks: peace and conflict; poverty and social justice; gender; diversity; environment and democracy and human rights. It also analyzes the methodologies proposed by the textbooks. The analysis concludes that although some areas, such as social conflict and poverty, and democracy and human rights are covered quite well, the approach to others is unsystematic or they are completely missing (in Catalan).

Observatories and other web resources

• Database on Conflicts and Peacebuilding

The purpose of the Database on Conflict and Peacebuilding is to assist in tracking and analyzing international conflicts. It is a bilingual project (Spanish and English) that provides information on approximately forty active armed conflicts around the world, roughly seventy situations of tension and some thirty peace negotiations, and deals specifically with the gender dimension of these contexts. The analysis for each conflict includes background information regarding its origins and evolution, the main actors involved, typology, intensity of the conflict and basic information on the country where it is taking place. In addition, the system offers access to periodical updates regarding the quarterly evolution of each case. Support for the project database is provided by the Norwegian Ministry of Foreign Affairs. • Conflict and Peacebuilding Observatory (No. 1-12)

Published monthly in Spanish and English, the observatory is a tool that promotes the understanding and comparison of contemporary forms of violence as well as providing visibility to the numerous talks and peace initiatives -including those driven by women- that are underway worldwide. Based on a dynamic map that identifies the cases that are relevant for each month, the observatory provides information and analysis on developments concerning the dynamics of conflict (fighting, victims, forced displacement, militarization, disarmament, etc.), peace negotiations, or gender issues related to violence and peacebuilding. The Conflict and Peace-building Observatory is supported by the Norwegian Ministry of Foreign Affairs.

• Transitional Justice Observatory (N°1 – 12)

This observatory monitors transitional justice processes worldwide. It delves into five classic dimensions of transitional justice: the prosecution of those responsible for war crimes or gross violations of human rights, either by the ICC, ad hoc courts, international courts or ordinary justice systems; Truth commissions; Reparation; Institutional reform; and Memory initiatives. The basis for the observatory is a world map that highlights the month by month behaviour of countries on these issues, and a monthly newsletter with the most important news from countries around the world, published in Spanish and English. Support for the Transitional Justice Observatory is provided by the Norwegian Ministry of Foreign Affairs.





• Conflict Transformation in the City

A research and informational web site on how to transform conflicts to improve social harmony in the city. It is aimed at care professionals (social workers, mediators, social educators, etc.). To this end, it provides tools and recommendations on the following topics: approaching the conflict from positive peace perspective; dealing with the dilemmas of participation; focusing on the needs; nonviolent communication; improving prevention; taking a multidimensional view of the conflict; viewing the crisis as an opportunity; overcoming preconceptions regarding the enemy; involving all stakeholders; diagnosing the situation; fostering the inclusive city; and conducting intervention assessments. This website, the result of a researchaction project, has been possible thanks to the support of the City of Barcelona.

Teaching and raising awareness Postgraduate degree in the Culture of Peace

In 2013 the ECP has organized many learning activities including the 14th edition of the Degree in the Culture of Peace which has been taken by over 700 people since its inception.

The degree, which includes 230 hours of study, has been divided into three parts: Fundamentals of Peace education and research; Analysis of armed conflicts and other types of violence; and Peacebuilding. The following prestigious experts and academic authorities have participated:

- "Culture of Peace" course. Delivered by Cécile Barbeito on January 10, 12 and 17, in the Casa Amarilla Civic Centre in Barcelona.
- 5th Conference on Creativity and Conflict, titled "Imagination and creativity in contexts of political violence" Organized in collaboration with Grupo de Educación para la Paz. 120 people participated on April 10 and 11 at the UAB, Barcelona.
- "Mediation is not everything: community conflict management from a broader perspective". The course was for company employees of Progess SL and took place in May in Barcelona. By Marina Caireta and Míriam Acebillo.

• Workshop on conflict sensitivity using the Do No Harm framework and the Peace and Conflict Impact Assessment methodology as part of the course "Peacebuilding Tools in Humanitarian Action", for 25 workers of NGOs. 27 September, organized by IECAH. By Cécile Barbeito and Gema Redondo.

• Workshop: "Leisure-time peace education." Two training workshops for civic centre educators in the district of Sant Martí de Provençals, and counselling to implement a service-learning project for peace from their installations. In Barcelona, September 26, and October 1, 8, 10, 15 and 17. By Cécile Barbeito. • Course: "Education for Peace and Creativity". 30-hour course organized by the Forca leisure-time school on November 16 and 17, aimed at leisuretime educators being trained to become directors. Instructional Materials

After participating in the effort to translate the game Belfedar into Spanish and Catalan, several activities were organized to introduce it to educators: four workshops in Catalonia and three in other parts of Spain (Basque Country and Madrid). This project is in collaboration with the Cooperative Artijoc and the Evens Foundation.



Actions Intervention in armed conflicts

The ECP has continued to collaborate in peacebuilding in some countries, either publicly or behind the scenes. Regarding Colombia, in addition to permanent contacts with various actors in the conflict and the peace process, the ECP participated in the co-organization of the European Peace Table in Barcelona, 23-24 May.

With regard to the peace process in the Philippines, a statement was signed together with International Alert, Conciliation Resources and the Centre for Peace and Conflict Studies, as members of the "Friends of the Peace Process", and addressed to the Philippine government in support of the dialogue between the government and the NDF, the political arm of the NPA guerrillas.

Consulting

• Consulting for the Norwegian Peacebuilding Centre: In 2013 the team from the Programme on Conflicts and Peacebuilding also carried out consultancy work for the Norwegian Peacebuilding Centre (NOREF).

• **Conflict sensitivity**: During the month of October Cécile Barbeito participated in two activities on conflict sensitivity run by the US organization CDA. In the first, she participated in the consultation process for the new Do No Harm trainer's manual. In the second, she attended a specialization course on Reflecting on Peace Practices.

Participation in networks

• **AIPAZ**: ECP researcher Pamela Urrutia became a member on the board of the Spanish Association for

Peace Research (AIPAZ) during the meeting that the organization held on November 29 in Barcelona, with other members of the team also participating.

• Catalan Federation of NGOs for Peace, Human Rights and Development (FCONG): ECP researcher Josep Maria Royo Aspa was ratified as a member (since 2012) of the Board of the Catalan Federation of NGOs for Peace, Human Rights and Development (FCONG) during the organization's general meeting in Barcelona on June 29. As part of this membership he has been the representative of the FCONG in Catalan Committee of Humanitarian Aid and Emergencies (CCAHE).

• Women's International League for Peace and Freedom (WILPF): ECP researcher Maria Villellas Ariño participated in meetings of the Spanish section of the Women's International League for Peace and Freedom. The WILPF was created in 1915, is present in 35 countries and has consultative status with ECOSOC, UNESCO and UNCTAD.

• Network of Entities for the Democratic Republic of Congo: The Conflict and Peacebuilding Programme also collaborated on the activities of the Network of Entities for the Democratic Republic of Congo, formed by various Catalan organizations and NGOs working in the areas of cooperation, raising awareness, filing complaints, research and intercultural communication in the conflict affecting the African country.

• The UN Academic Advisory Council on Mediation Support Unit: ECP researcher Jordi Urgell García participated in the session of the UN Academic Advisory Council on Mediation held in April in New York. This body has the mission of providing guidance for the United Nations, and especially the Department of Political Affairs, on mediation and conflict resolution. • **State of Peace Seminar**: Jordi Urgell also regularly participated in the State of Peace Seminar (Estat de Pau), which aims to reflect on issues of defence and security from the viewpoint of the movement for peace.

• Competencies and Education for Development programme: Edualter and the ECP's Education for Peace Programme organized six sessions of consultation with specialists in education for peace (1 and 17 October), intercultural education (29 October and 14 November), and environmental education (28 November and 12 December), to gather suggestions on how to develop a school curriculum on these three issues.
